RESULTS OF THE APRIL 2024 AUCTIONS FOR FIRSTENERGY'S PENNSYLVANIA DSP-VI DEFAULT SERVICE PROGRAM

As the Independent Evaluator, CRA International, Inc. d/b/a Charles River Associates ("CRA"), completed the Default Service solicitation on behalf of the rate districts for FirstEnergy Pennsylvania Company — Metropolitan Edison ("Met-Ed"), Pennsylvania Electric ("Penelec"), Pennsylvania Power ("Penn Power"), and West Penn Power ("West Penn Companies"). The DSP-VI Residential/Commercial (Fixed-Price) Auction and Industrial (Hourly-Priced) Auction was conducted on April 15, 2024.

Through this auctions process for their Default Service Programs DSP-VI, the Companies sought to procure full requirements Default Supply generation service for their Default Service Customers for the period June 2024 through May 2026.

On April 17, the Pennsylvania Public Utility Commission, via a Secretarial Letter, announced that it accepted the results of the auctions. The results are summarized in the table below.
