On April 15, 2025, FirstEnergy Pennsylvania Electric Company (FEPA), on behalf of its four rate districts of Metropolitan Edison Company (Met-Ed), Pennsylvania Electric Company (Penelec), Pennsylvania Power Company (Penn Power), and West Penn Power Company (West Penn), filed the results of its Request for Proposals Process and Rules for the April 2025 Solicitation for provider of last resort service. The filing includes bid results of twenty products in two declining clock auctions: sixteen products in a Fixed Auction for a full requirements product for the supply for residential and commercial customers who will receive default service from FEPA within the period June 1, 2025 through May 31, 2027 and four products in an Hourly Auction with an hourly priced product for FEPA's industrial customers for the 12-month period June 1, 2025 through May 31, 2026.

This filing was submitted in accordance with the RFP Process and Rules filed by Met-Ed, Penelec, Penn Power, and West Power (now FEPA). The RFP Process and Rules were filed pursuant to the Commission's Order, entered August 4, 2022, at Docket Nos. P-2021-3030012, P-2021-3030013, P-2021-3030014 & P-2021-3030021.


FEPA requests that the Commission approve the bid results from the April 2025 Solicitation on or before April 16, 2025.

Further investigation does not appear to be warranted at this time, since the bid results from the April 2025 Solicitation appear to have been conducted in accordance with the RFP Process and Rules as approved by the Commission.

Therefore, we direct FEPA to disclose the results of the April 2025 Solicitation in accordance with the Commission's Secretarial Letter in Re: Disclosure of Default Service Solicitation Results and Creation of a Default Service Rate Calculation Model, issued October 12, 2010, at Docket No. M-2009-2082042.
