Dear Ms. Giesler:

On April 14, 2015, Metropolitan Edison Company (Met-Ed), Pennsylvania Electric Company (Penelec), Pennsylvania Power Company (Penn Power) and West Penn Power Company (West Penn) (collectively, First Energy) filed the results of their Request for Proposals (RFP) Processes and Rules (April Solicitation) for provider of last resort service. The filing includes proposed bid results for Full Requirements RFP for all First Energy Residential and Commercial Customers electing to receive default service from First Energy beginning June 1, 2015, at Docket Nos. P-2013-2391368, P-2013-2391372, P-2013-2391375 and P-2013-2391378 (P-2013-2391368 et al).

First Energy requests that the Commission approve the bid results from the April 2015 Solicitation on or before April 15, 2015.

Further investigation does not appear to be warranted at this time, since the bid results from the April 2015 Solicitation appear to have been conducted in accordance with the RFP Process and Rules, filed pursuant to the Commission's Opinion and Order.


